


More About Awards & Scholarships

The NASCOE Awards & Scholarships portal is now live, with a submission deadline of January 15, 2026 at 11:59 PM ET. These programs recognize outstanding service and provide valuable educational support for NASCOE members and their families.

Distinguished Service Awards (DSA)

Help recognize the dedication of a coworker through the DSA program, honoring service to NASCOE, FSA-Agriculture, and the community. Any NASCOE member in good standing may nominate a fellow member. Retired members from the current year are also eligible.

Sick Leave Awards

These awards honor NASCOE members with significant unused sick leave, starting at 1,000 hours. Certificates and medallions are awarded, with a submission deadline of July 1, 2026.
